Information and Instructions for Associate Member Application

Dues Rates*	
Use the following information to determine annual dues	
Annual Sales Revenue	Dues
\$20M or less	\$2,750 + \$1,250 per \$Million in sales
Over \$20M up to and including \$40M	\$27,750 + \$400 per \$Million in sales over \$20M
Over \$40M	\$35,750 + \$100 per \$Million in sales over \$40M

* All monetary values are \$USD.

Basis for Dues Calculation ▪ Associate member dues are based on the amount of revenue generated from all sales or products or services related to the manufacturing of concrete products and from the installation of such products. All sales in the U.S. and Canada are considered, but sales related to masonry construction and concrete block production in Canada are excluded if the Associate Member is also a member of the Canadian Concrete Masonry Producers Association. For those Associate Members who are associated with a parent company that also maintains a Producer membership, internal sales are excluded from reported sales revenue. Companies that are producer members and also choose to be associate members shall pay additional dues based on the table above.

Membership Qualifications ▪ Associate membership is open to suppliers of products and services to producers and installers of manufactured concrete product systems.

Membership Dues Year ▪ The CMHA dues year extends from July 1, 2024 to June 30, 2025.

Example Calculations ▪ The following examples are provided to illustrate the dues calculation procedure.

Example 1

The associate has \$8,500,000 in sales in the last fiscal year to the industry.

DUES CALCULATION EXAMPLE 1	
GROSS SALES TO INDUSTRY - <u>\$8.5 Million USD</u>	
TOTAL DUES ▪ $\$2,750 + (\$1,250 \times 8.5) = \$2,750 + \$10,625$	<u>\$13,375 USD</u>

Example 2

The associate has \$35,500,000 in sales in the last fiscal year to the industry.

DUES CALCULATION EXAMPLE 2	
GROSS SALES TO INDUSTRY - <u>\$35.5 Million USD</u>	
TOTAL DUES ▪ $\$27,750 + (\$400 \times 15.5) = \$27,750 + \$6,200$	<u>\$33,950 USD</u>
